IV. Goals of the project

The project based on the results of the REgional and International Integrated Telemedicine Network for Medical Assistance in End Stage Diseases and Organ TRANSPLANT, RETRANSPLANT project (HC - IN 4028) sponsored by the European Commission Information Society Directorate-General.

The RETRANSPLANT (<http://retransplant.vitamib.com>) project aimed to develop and install telematics tools to bridge the various and geographically dispersed institutions playing a role in the complex process of organ collection from a donor and transplantation into one or several recipients. The major integrated achievement of the project was to create a continuum between the patients and health professionals SmartCard, the Electronic Patient Record shared through Internet and a Transplant Information Portal including several web-based services that are actually used by the concerned healthcare actors.

In the aEastern and Central European associated states the national organ transplant organisations have a loose collaboration to serve around 60 million habitants. Hence the existing national waiting lists are relatively short, and the national health care systems are providing well-organized dialysis services for patients with end stage kidney diseases and they have a good chance for kidney transplant in a reasonable timeframe.

Partners in the IKTA 4 proposal would like to continue a nationwide network development to able to interconnect all organizations from the dialysis centers, tissue typing laboratories, donor hospitals, and transplant centers at the national level in Hungary. The proposal's goal to continue the development of a WEB Information Portal (Transplant Information Portal) based on the following criteria:

1. Adopt the RETRANSPLANT tools to Hungarian environments and requirements.
2. Integrated the existing four transplantology centers (Budapest, Debrecen, Pecs, Szeged)
3. Develop a network of the donor hospital's intensive care unit to enhance the efficacy of the organ donation.

4.4. Continue the integration of the different dialysis organizations using the WEB electronic patient record and make it accessible for all dialysis centers nationwide.

5. Completion and continuation of a secure WEB portal and network development particularly paying attention to the new legislation and national laws and focusing on the use of professional and patient smart or chip cards in the daily practice.
